RELEASE OF LIABILITY FOR LOCAL OFF-CAMPUS ACTIVITIES

During the course of the 2011-2012 academic school year, teachers will organize field trips which will occur primarily during the school day. Such field trips are intended to enhance the programme of study in which the student is engaged. Details pertaining to field trips will be sent home approximately two weeks prior to the trip taking place. Some students will also be travelling to various venues for athletics events. Details relevant to athletic trips will be addressed through permission forms sent home by the athletic department, prior to the event taking place. *(Please note that specific field trips and athletic trips will involve additional paperwork and your review and approval will be required.)*

Throughout this Release I understand that:

1. "Webber Academy" refers to the Webber Academy Foundation, its offices, directors, employees, agents, volunteers, or representatives;
2. "my Child" refers to the child or charge for whom I am legally responsible;
3. "Off-Campus Trip" or "Off-Campus Trips" refers to all off-campus activities, courses or events offered to my child as part of the academic extra-curricular or other out-of-school programs sanctioned by the directors, officers and employees of Webber Academy;

In consideration of Webber Academy offering off-campus courses and activities for my Child, I AGREE TO THIS RELEASE OF ALL CLAIMS AND LIABILITY in favour of Webber Academy, which Release is binding with respect to all "off-campus trips" in which I allow my Child to participate during the 2011-2012 academic year.

I understand that Off-Campus Trips involve certain dangers, not all of which can be listed here. Among the more obvious and frequent are:

- Exposure to variable extremes in weather that may cause injury due to heat or cold, and which may prevent or force route and itinerary changes;
- Falls or other accidents due to uneven or hazardous terrain;
- Either due to deliberate disobedience or other cause, my child may become separated from the party;
- Travel in remote locations with poor communications and inability to get rescue or medical assistance easily or quickly;
- Accidents; and
- Illness

I, on my own behalf, and on behalf of my Child understand and accept the dangers, risks and hazards of these Off-Campus Trips and the possibility of death, personal injury, property damage and loss which may result.

For each Off-Campus Trip in which I allow my Child to participate, I agree to release Webber Academy from any and all liability for any personal injury, death, property damage or loss which I or my Child may suffer as a result of my Child's participation in the Off-Campus Trip. I and my Child waive any claims associated with any such injury, death, damage or loss suffered on or as a result of an Off-Campus Trip for any cause whatsoever, whether such claim arises from mistake, error in judgment, negligence, by contract, by tort, in equity or by reason of breach of a legal or statutory duty.

In allowing my Child to participate in any of the Off-Campus Trips, I acknowledge and hereby represent that my Child is physically capable and fit to participate in the Off-Campus Trip and has no medical conditions or needs other than those of which I informed Webber Academy by completing its medical questionnaire.

I agree that by signing this Release as a parent or legal guardian for my Child who is under 18 years of age, I will pay for all costs incurred by Webber Academy by reason of any emergency medical treatment or evacuation with respect to my Child.

I further agree to hold harmless and indemnify Webber Academy for any and all liability for any losses, property damage and personal injury to other third parties, including costs of any litigation resulting there from, which results from the participation of my Child in any Off-Campus Trip.

I confirm that I have read over this agreement before signing it and I understand that this Release waives certain rights which I or my Child might otherwise have against Webber Academy. I understand that this Release can be raised as a complete bar to any legal proceedings contemplated by this Release. I further understand that this Release is binding, not only on me, but also on all my legal representatives now and for the future.

I agree that this Release will be governed exclusively by and interpreted solely in accordance with the laws of the Province of Alberta.
